EMCS: Excise Movement and Control System

According to the European Union, the movement and storage of excisable goods under duty suspension for the authorities must be traceable.

Excise goods are tobacco products, alcohol and alcoholic beverages as well as energy products. For this purpose, the mandatory IT procedure Excise Movement and Control System (EMCS) was introduced, which facilitates control throughout the EU.

Use functions

With the help of EMCS, a movement of excisable goods under duty suspension between two traders is documented with the help of IT. From the issuing by the consignor to the acknowledgement of receipt by the consignee.

The EMCS module in our certified participant software FORMAT-IVEAS provides you with convenient and easy-to-integrate electronic processing. The exchange of information with the German customs authorities is fully automated.

A template for the electronically accompanying administrative document (e-VD) can be generated from the data of the respective ERP system and transmitted to the competent authority. The validity declaration from the authority is read into the system and processed accordingly.

A supplementary check of the consumption tax number can also reduce the risk of supplying non-authorized persons due to incorrect information.

The software solution can be easily integrated into the respective system environment. It can, of course, also be installed as an independent stand-alone solution.


